**Sex Trafficking & Exploitation** 

Conference East Auburn Baptist Church March 21st. 2019: 9-3:30

This conference supports efforts to establish a coordinated community response to trafficking and exploitation in the Tri-County area. Presentations will



focus on the ways in which law enforcement and the Department of Corrections may have contact with individuals involved in sex trafficking and exploitation. Participants will hear from speakers, law enforcement and survivors of sex trafficking and exploitation, to enhance knowledge and identification, further illustrated by the use of a regional case study. This conference is a collaborative effort between Safe Voices, SAPARS and local law enforcement in partnership with Federal agencies.

#### <u>Alleged victim in sex trafficking case of Lewiston man</u> <u>reported dead day before trial</u> Lewiston Sun Journal - March 11, 2019

"Police wrote in an affidavit that Gerding had boasted to an undercover police officer posing as a prostitute in downtown Lewiston one night in September that he provided protection for some of the prostitutes in the area. He said he had two 'girls' working the streets. He said he wasn't afraid to get physical with some or 'put a gun in someone,' according to the affidavit."

### Bill proposed to decriminalize prostitution WABI 5 - March 7, 2019

"One bill would decriminalize prostitution and change the law from using the word prostitute to 'prostituted person.' Another bill would prevent law enforcement from charging minors for prostitution. Supporters contend sex workers are often victims of human trafficking."
