### THE FUND

[The Fund](#) is a flexible, accessible, and timely source of funds to support the immediate needs of victims of trafficking as they seek to increase their safety and start a new life.

Direct service providers and law enforcement officers from across Maine can apply to access these funds on behalf of individuals who have a demonstrated need and who are victims of sex trafficking, labor trafficking or commercial sex exploitation.

### FY21 SUMMARY

During the 2021 fiscal year we spent a total of \$36,668.50. The fund served 21 individual people with 83 immediate needs. Those needs included shelter, healthcare, clothing, phones, food, home needs, and much more! Additionally, we added a few new pre-approved items to the needs list such as baby supplies, train tickets, and hygiene products.
